Title of Study: Awareness of Neuropsychological

Function in Coronary Artery Bypass

Graft Surgery

Abstract

Changes in brain function after Coronary Artery Bypass Surgery have been documented in several studies from the late 1970's to the present. The present study attempts to document if neuropsychological changes occur as a result of bypass surgery. investigations of neuropsychological alterations following bypass surgery were limited to only a few psychometric measures to detect such changes. present study incorporates a computerized neuropsychological test battery that is sensitive to subtle changes. Twenty-eight subjects, fourteen cardiac bypass surgery subjects and fourteen angioplasty subjects, were tested on six tasks sensitive to performance. After completing each task, subjects rated their performance. Results showed significant differences in actual performance between the two groups for three of the six tasks. The subjective ratings of performance yielded significant differences on only one task. The present study concludes that cardiac bypass graft surgery appears to lead to neuropsychological changes, this resultant change seems to be perceived the subject.
